- 3. The reason (listed on the application) for the proposed change of organizations is: This annexation was initiated by several property owners as well as the City of Bakersfield to provide additional lands to accommodate the City's 6<sup>th</sup> cycle vacant sites inventory as part of the California state-mandated Housing Element Update.
- 4. Thirteen parcels can be determined to be surrounded by the City of Bakersfield. It would better serve the community if public services to the area were the responsibility of the same provider as the surrounding areas. The County has requested dissolution of CSA 71.
- 5. As a responsible agency, LAFCo will be reviewing the environmental documentation, adopted by the lead agency.
- 6. The proposal area is generally located: Northwest corner of Snow Road and Calloway Drive. A total of 92.37 acres.
- 7. Due to the proposed territory being an unincorporated island, surrounded by city, and if the Commission finds that the annexation meets all criteria, the protest hearing will be waived pursuant to Government Code 56375.3(a) of the Cortese-Knox-Hertzberg Reorganization Act of 2000. Property owners and residents will not have a venue to protest this action.
